## Support from Our Readers, Donors, and Advertisers Allows Us to Fulfill Our Mission

### Snapshot of 2024 News Coverage

The reenergized *Lakeville Journal* and *Millerton News* dug deeply into an impressive variety of topics that are of vital interest to the communities they serve. These included the threat that invasive hydrilla weed poses to our waterways, the EMS cost crisis in Millerton and beyond, and policy changes in our schools. We continue to cover key projects taken up by our Planning and Zoning Boards such as the proposed redevelopment of the Wake Robin Inn in Lakeville, and efforts to fund and rebuild the pool at Eddie Collins Park in Millerton. And much more.

### Food Access

Without a grocery store, Millerton has been described as a food desert. Residents have had to travel long distances to buy groceries. In December, we reported on the plans by a Sharon couple to open a full-service grocery store in a former supermarket site and construction is underway.

### Land Use

Last fall, *The Lakeville Journal* documented a battle between those defending agricultural land protections and property owners seeking to build a house on protected farmland. This series of stories traced a 1984 farmland protection easement and the actions brought by a local land trust for stricter enforcement of easements.

### Energy/Environment

Throughout 2024, we tracked developments on the solar energy front. In Connecticut towns and in northern Dutchess County, efforts to install solar farms — small, medium and large in scope — met with success and failure. In one case, a Connecticut municipality built a solar farm at its transfer station. In another, a project linked to a school hit a big obstacle late in the game. After significant local opposition, a Dutchess County town approved a 10-megawatt solar farm on farmland, while in Columbia County, a battle to stop a 42-megawatt facility — also on farmland — in Copake continues.

### Housing

We chronicled the progress of various groups to provide affordable housing in our communities. In July 2024 we wrote about Habitat for Humanity's completion of a home in North Canaan and plans for another. We documented a land donation by the Town of North East that led to the construction of the first single-family affordable home in Millerton by Habitat for Humanity of Dutchess County.

In November we highlighted resources available to combat the growing homelessness problem. We also told the story of a Waterbury family who sleeps in a tent city and takes a bus every day to a shelter in Torrington.

### Health

After a long bid to close its labor and delivery unit, Sharon Hospital was denied its petition by state regulators. *The Lakeville Journal* covered the community's response to the hospital's plans, along with the extensive state review and decision. Ultimately, the hospital's parent reached an agreement to merge with a much larger healthcare network in New York state. Throughout, the stories revealed the challenges, struggles and threats the community faces in what has become a rural healthcare crisis. In response, we reported on the opening of the Community Health and Wellness Center in Canaan.

## Community Engagement

During the summer, we met with residents in Norfolk and Millerton to hear about what they need from their regional, community news source. We convened our annual festive gathering of local nonprofits at the Street Fair in Salisbury. In October, we presented the inaugural Estabrook Community Leadership award to the Harney family at a Jubilee Country Luncheon.

## Sustainability

We took important steps to secure our own future during challenging times for publishers. We launched two new websites, professionalized our fundraising efforts, and established the community-based events that keep us connected to readers, supporters, advertisers, and fellow nonprofits.

We have also identified additional board members rooted in our communities. This year, we welcomed Henry Blodget of West Cornwall, Rob Fish of Salisbury, Meg Downey of Millerton, Scott Siegler of Sharon and Dick Hermans of Pine Plains.

Generous grants are helping to stabilize our infrastructure, including multi-year support from the Foundation for Community Health, along with contributions from Cowles Charitable Trust and The Miami Foundation. The Google News Initiative is supporting website improvements, and LION Publishers is helping to fund upgrades to our financial systems.

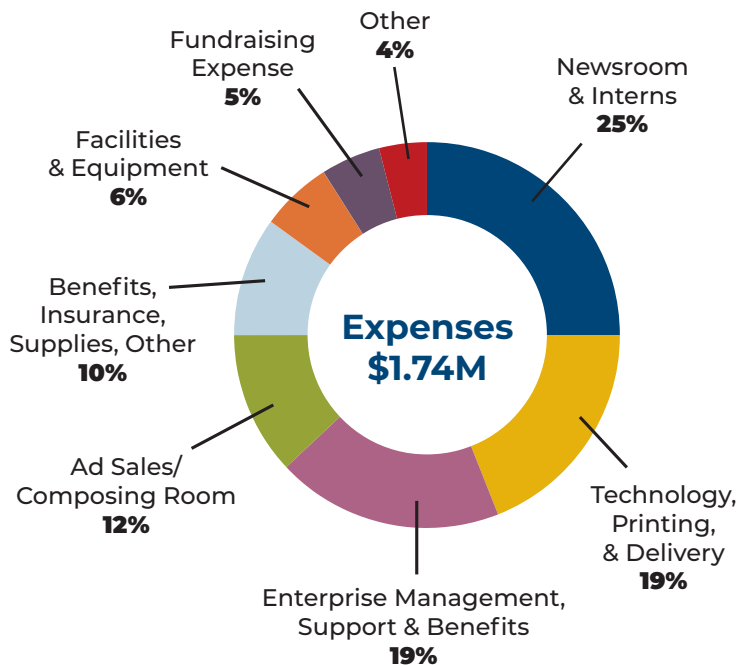
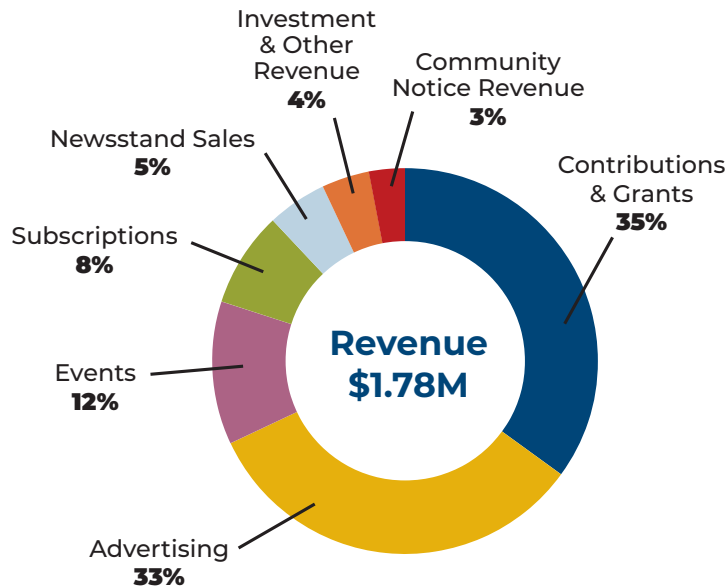
